
### 2.1.2 Analysis Techniques




Fig 10: How frequently do you experience noise disturbances in your rented apartment




Fig 11: What sources of noise disturb you most often




Fig 12: On a scale of 1 to 5, how significantly does noise affect your daily activities




Fig 13: Have you previously tried any soundproofing solutions in your rented apartment





Fig 14: If yes, what soundproofing methods have you used?




Fig 16: What factors are most important to you when considering soundproofing solutions





Fig 17: Would you be willing to try DIY soundproofing methods that use household items bookshelves along shared


